

**Ordinance of the County Board
Of
Kankakee County, Illinois**

Re: AMENDMENT TO COUNTY CODE, HEALTH DEPARTMENT FOOD SERVICE ESTABLISHMENT LICENSES AND FEES, SECTIONS 18-1, 22-49(c) and 22-55

WHEREAS, under the authority of the Illinois Food Handling Regulation Enforcement Act, 410 ILCS 625.01 et seq. and the Sanitary Food Preparation Act 410 ILCS 650.01 et seq. Counties may by ordinance determine the amount of fees to be charged for the exercise of powers under the Acts, and

WHEREAS, the Executive Committee of the County Board, at its duly noticed regularly scheduled meeting of September 24, 2015, after review, discussion and consideration recommended the adoption of amendments to County Code, by amending Section 22-49(c)(3) frequency of inspection for low risk Category I establishments from one time annually to every two years to reflect current state law, 77 Illinois Admin. Code 615.310, and changes of name only without significant changes to the operation as determined by the Department under Submission of construction plans Section 22-55, a fee shall be charged, and

WHEREAS, the Committee further recommended increases in certain fees under Section 18-1 for Section 22-84(c) Health Code annual license fees for food service establishments for retail food stores, for mobile food units and plan review fees by increasing the fees for annual licenses retail food stores for Category III from \$150.00 to \$200.00, for Category II from \$200.00 to \$300.00, for Category I from \$250.00 to \$350.00; for mobile units for Category III from \$150.00 to \$200.00, for Category II from \$200.00 to \$300.00, for Category I from \$250.00 to \$300.00; and for Plan Review Fees for Category III from \$150.00 to \$200.00, for Category II fees from \$200.00 to \$300.00, for Category I from \$250.00 to \$300.00, increasing late fees not submitted by January 15 from \$25.00 to \$50.00 and after January 31 from \$50.00 to \$100.00, and adding a change of ownership only fee for all Categories of \$100.00 for those changing the name only without significant changes to the operation.

NOW, THEREFORE, IT IS HEREBY ORDAINED that after review, discussion and consideration the County Board of Kankakee hereby amends the County Code by the amendment of the following sections on Health Code Annual License Fees for mobile food units and Plan Review Fees in Section 18-1 under Section 22-84(c) of the County Code as follows:

Additions (underlined) and deletions (strike) to Section 18-1 under, Section 22-84(c), 22-49(c)(3), 22-55.

Section 22-49 (c)(3)

(3) Category III (low risk facilities): ~~One-time annually~~ Every two years.

Section 22-55. Submission of Construction plans.

Whenever a food service establishment, retail food store, temporary food stand, mobile food unit is constructed, extensively remodeled, changes ownership or changes name without significant change to the operation as determined by the Department, and whenever an existing structure is converted to use as a....
